
I am also pleased to report that the majority of your current committee members have indicated that they are happy to continue to serve you for another twelve months and I would encourage all members to support and applaud their efforts.



A New system for membership renewal online for 2022/3

This year you will need to complete the online risk acknowledgement to renew your club membership. A full explanation behind this move was included in March 2022 Footprints

To do this:

- Go to www.borderbushwalkingclub.com.au
- From the top menu, select 'Members' and then 'Online membership renewal'.
- You should see a login option on the right of your screen. Login.
 - If you have forgotten your password, select 'forgot password' and enter your login name or email. You will be emailed a password reset – this might have gone to your junk email folder.
 - If you have forgotten your username, select 'forgot password', enter your email address, and your username will be on the email that you receive. Then do the prior step if you've also forgotten your password.
- Once you have logged in you will see the risk acknowledgement information.
- Read the risk acknowledgement and tick the box to confirm you have read and acknowledge the risk acknowledgement statement.

I am carrying food, water, medication, and equipment appropriate for the activity."

- Transfer your membership fee using the club's bank account details as shown and tick the box confirming this (or n/a – I am a life member).
- The field with today's date should have auto-filled – you don't need to change this unless it's incorrect.
- Complete the 'captcha' (you can skip this by pressing and holding down your mouse button for a couple of seconds where it says 'I am not a robot') and submit the form.
- Your membership has now been renewed. If there have been any issues with the form or payment going through, this will become apparent if/when you receive a reminder email to renew [this 'exception' process is less work for our membership officer than emailing to confirm every membership].

If you have any concerns with completing the risk acknowledgement, please contact the committee via the Contact form (Menu toolbar > Contact).

Activities Report.....David

Following last year's AGM, Bernadette vacated the Activities coordinator role and I took it back on for my second stint.

Unfortunately the first six+ months to October/November were a real headache for Leaders and myself trying to make sense of frequently changing rules and restrictions, with many activities during this time being cancelled or postponed.

Nevertheless, as the statistics below show, we still managed to get in 45+ walks/rides/overnighters over the year as well as multiple canoeing trips.

Thanks to all our Leaders for your contribution, and participants for coming along for the walk/ride/canoe/... I would like to call out and recognise:

- Eileen for her ongoing work in keeping the lists below (stats) of where we've been going,
- Sasho and Catherine for leading the many canoeing activities (which have sadly now ceased),
- Mick and Deb for leading some interesting trips further afield (Mt Howitt / Vallejo Gantner, Tali Karng), and
- Leanne for starting to lead walks – including her 'singing ambles' which are a unique addition to the program and yet another way of connecting with nature.

Hopefully the year ahead will start getting back to 'normal', or at least whatever the 'new normal' is. However I know that many of our Leaders and club members have travel planned in coming months, so the club program for winter at least may still be on the quiet side.

In September we will hopefully have a Leaders training day – tentatively scheduled for 17 September. This will be relevant for not just current/potential Leaders, but also (as Bernadette described last year) for anyone who wants to brush up on bushwalking skills and stay safe, wants to give more to the club or wants to understand more about what leaders are doing behind the scenes.

We will then have some of our Leaders and hopefully members participating in the October Federation Walks weekend.

In addition, this year the new risk acknowledgement process will take effect from May with membership renewals. This will cut down on the 'paperwork' while still maintaining risks are appropriately considered and managed.
